Verdant Creations, LLC Rules and Regulations: Ohio Revised Code and Board of Pharmacy Regulations

<u>Medical Marijuana Establishment:</u> Verdant Creations, LLC is a Medical Marijuana Establishment dedicated to providing the highest quality of medicine and services for qualified medical marijuana patients, consistent with the limitations and rights established by the Ohio Medical Marijuana Control Program and regulations set forth in the Ohio Revised Code. The following rules and regulations apply to all patients and caregivers that enter this dispensary. Any violation of these rules is grounds for immediate termination of any legal relationship between the parties. Verdant Creations, LLC reserves the right to refuse service to any person at any time for any reason.

Recommendations and Confirmation of Diagnosis: Patients of Verdant Creations, LLC must have a recommendation and certification for medical marijuana by a licensed physician, and a state-issued Medical Marijuana Identification Card as required by the State of Ohio's Laws and Regulations. Patients must provide Verdant Creations, LLC with a currently valid state identification card, Driver's License, or passport, along with their currently valid Ohio Medical Marijuana Identification Card upon each visit to Verdant Creations, LLC to purchase medicine.

<u>Confidentiality:</u> All personal information collected by Verdant Creations, LLC is confidential and private, except that it is shared with other medical marijuana entities in Ohio via the state's secure online tracking system. Such information will not be released to any third party without your express written consent. However, patients understand that Verdant Creations, LLC may be forced by court order or the Ohio Board of Pharmacy to release certain information and that Verdant Creations, LLC will comply in this regard.

<u>No resale, redistribution, or driving impaired:</u> Resale or redistribution of any products received from Verdant Creations, LLC is strictly prohibited. Patient agrees that Patient shall not operate a motor vehicle or heavy equipment while impaired by medical marijuana. Patients and caregivers shall indemnify, defend, and hold harmless Verdant Creations, LLC to the maximum extent allowed by law from any damages caused by the Patient operating a motor vehicle or heavy equipment while impaired by medical marijuana.

<u>Prohibited forms of medical marijuana</u>: The law prohibits the use of medical marijuana by smoking or combustion but does allow for vaporization (vaping). The law prohibits any form that is attractive to children.

No cell phones, cameras, recording devices, or weapons: No cell phones, cameras, electronic communication devices, or recording devices are permitted to be used inside the dispensary at any time without the express consent of the Dispensary Manager. No weapons of any kind are permitted on the premises at any time.

<u>No public use or onsite consumption:</u> The use of medical marijuana in public view is illegal. Consumption of medical marijuana, illegal drugs, tobacco, or alcohol anywhere on this site is strictly prohibited. Consumption of medical marijuana or illegal drugs is strictly prohibited on the entire site of the dispensary.

<u>Payment for services</u>: The payments made to Verdant Creations, LLC for medical marijuana---related products and services include fees for the Dispensary's professional consulting services, overhead, expenses, and other related costs of providing these services. Payment is expected at time of service.

<u>No Touching:</u> Patients are not allowed to touch any of the items containing medicine until their transaction has been completed. Patient transactions will be denied if any illegal activities are alluded to or suspected during the time of sale.

Safe Use: At all times, keep medication out of the reach of children and in child-proof packaging.

<u>Adverse Reactions:</u> For any adverse reactions call the Board's toll-free number (1-833-464-6627) and also contact your recommending physician if side effects or contraindications occur.
